





### Q3 Which of the following best describes your gender?







### Q5 What best describes your political affiliation?





### Q6 Did you vote in the last U.S. presidential election (in 2016)?







## Q10 Did you attend graduate school and receive a Masters or PhD before applying to law school?







### Q12 Did you take the LSAT or GRE?





## Q13 Which of the following reasons best describes why you did NOT consider taking the GRE when applying to law school?





### Q14 Why did you take both the LSAT and GRE?










### Q17 Do you intend to practice law after you graduate from law school?


